FOR THREE-YEAR-OLDS AND UPWARD By subscription of \$400 each, which shall accompany the nomination or by supplementary nomination of \$4,000 each by closing time of entries, and \$6,000 additional to start, with \$400,000 Guaranteed, of which \$240,000 to first, \$80,000 to second, \$48,000 to third, \$24,000 to fourth and \$8,000 to fifth. Three-year-olds 122 lbs.; Older 126 lbs. Non-winners of a Grade I since November 1, 2023 allowed 2 lbs.; of a Grade II in 2024 or a Grade I in 2023, 4 lbs. STARTERS TO BE NAMED THROUGH THE ENTRY BOX WEDNESDAY JULY 24 BY THE CLOSING TIME OF ENTRIES. The Bing Crosby Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Bing Crosby Stakes will be entitled to automatic entry into the 2024 Breeders' Cup Sprint. The nominated winner will also be entitled to have pre-entry and entry fees waived for the Breeders' Cup Sprint or will receive a credit equal to the Breeders' Cup Sprint pre-entry and entry fee amount towards any other 2024 Breeders' Cup Championship Race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2024 Breeders' Cup World Championships held at Del Mar on November 1 and 2, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 21, 2024. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out-of-competition testing by the Horseracing Integrity & Welfare Unit on behalf of the Horseracing Integrity and Safety Authority (or their respective designees).
