FOR GOLDEN STATE ELIGIBLE CALIFORNIA BRED OR CALIFORNIA SIREB FILLIES AND MARES THREE YEAR OLDS AND UPWARD By subscription of \$100 each to accompany the nomination or by supplementary nomination of \$1,000 for Golden State eligible horses by closing time of entries. (Non-Golden State eligible horses, \$25,000 to supplement -- which will make that horse eligible to all future Golden State Series Stakes) \$1,500 additional to start, with \$100,000 Guaranteed, of which \$57,000 to first, \$19,000 to second, \$12,000 to third, \$6,000 to fourth, \$4,000 to fifth and \$2,000 to sixth.
